Item 1. Security and Issuer.

Item 1 of the Schedule 13D is hereby amended and restated as follows:

This Amendment No. 7 to Schedule 13D ("Amendment No. 7") is being filed by the undersigned, pursuant to §240.13d-2(a), with respect to the common stock, par value \$1.00 per share (the "Shares"), of Altisource Portfolio Solutions S.A. (the "Issuer" or the "Company"), whose principal executive offices are located at 40, avenue Monterey, L-2163 Luxembourg, Grand Duchy of Luxembourg. This Amendment No. 7 amends and supplements the Schedule 13D filed by the Reporting Persons with the Securities and Exchange Commission (the "SEC") on August 17, 2018, as amended by Amendment No. 1, filed with the SEC on August 24, 2018, Amendment No. 2, filed with the SEC on August 30, 2018, Amendment No. 3, filed with the SEC on September 27, 2018, Amendment No. 4 filed with the SEC on November 4, 2019, Amendment No. 5 filed with the SEC on March 17, 2020, and Amendment No. 6, filed with the SEC on May 11, 2020 (collectively, the "Schedule 13D").

Except as specifically provided herein, this Amendment No. 7 does not modify any of the information previously reported in the Schedule 13D. Capitalized terms used but not defined in this Amendment No. 7 shall have the meanings given them in the Schedule 13D.

Item 3. Source and Amount of Funds or Other Considerations

Item 3 of the Schedule 13D is hereby amended and supplemented by adding the following:

The funds used for the purchase of the Shares reported herein by the Reporting Persons were the working capital of the STS Master Fund, which may have included margin account borrowings made in the ordinary course of business. In such instances, the positions held in the margin accounts are pledged as collateral security for the repayment of debit balances in the account, which may exist from time to time. Because other securities are held in the margin accounts, it is not possible to determine the amounts, if any, of margin used to purchase the Shares reported herein. A total of approximately \$1,041,386.96 excluding commissions, was paid to acquire the Shares reported in Item 5(c) of this Amendment No. 7.

Item 5. Interest in the Securities of the Issuer

Items 5(*a*), (*b*) and (*c*) of the Schedule 13D are hereby amended and supplemented by adding the following:

(a, b) As of the date hereof, each of Deer Park, DPRM, DPRC, Mr. Craig-Scheckman, and AgateCreek may be deemed to be the beneficial owner of 3,737,631 Shares (approximately 23.9% of the total number of Shares outstanding).

As of the date hereof, Mr. Burg may be deemed to be the beneficial owner of 3,746,140 Shares (approximately 24.0% of the total number of Shares outstanding). This amount includes (i) 3,737,631 Shares he may be deemed to share voting and dispositive power with each of Deer Park, DPRM, DPRC, Mr. Craig-Scheckman, and AgateCreek, and (ii) 8,509 restricted Shares that were awarded to Mr. Burg in connection with his service as a non-management director of the Issuer.

The beneficial ownership percentage is based on a total of 15,631,557 Shares outstanding as of July 31, 2020, as disclosed in the Issuer's Form 10-Q, as filed with the SEC on August 6, 2020.

(c) On August 14, 2020, STS Master Fund purchased 117,875 Shares in the open-market, through a broker, at a weighted average price of \$8.8347 per Share. The actual prices range between \$8.35 to \$8.90. The Reporting Persons further undertake to provide upon request by the Commission staff, the Issuer, or a security holder of the Issuer, full information regarding the number of Shares purchased at each separate price reported herein.
